# POLICIES PERTAINING TO CHRISTIAN MARRIAGE

The ministers of this church welcome the opportunity to assist those who desire a Christian marriage and who intend to establish a Christian home, assisting them to prepare for and to enter into this sacred relationship. In fulfilling their pastoral ministries, the ministers will be guided by the standards for Christian marriage as set forth in the "Directory for Worship" of the Presbyterian Church (USA).

The following paragraphs from Chapter IV of the "Directory for Worship" delineate the principles which constitute the norm for weddings in the First Presbyterian Church of Bismarck.

## I. Marriage

- A. Marriage is a gift God has given to all humankind for the well-being of the entire human family. Marriage is a civil contract between a woman and a man. For Christians marriage is a covenant through which a man and a woman are called to live out together before God their lives of discipleship. In a service of Christian marriage a lifelong commitment is made by a woman and man to each other, publicly witnessed and acknowledged by the community of faith.
- B. In preparation for the marriage service, the minister asked to lead the service shall provide for a discussion with the man and the woman concerning
- the nature of their Christian commitment, assuring that at least one is a professing Christian,
  - the legal requirements of the state,
  - the privileges and responsibilities of Christian marriage,
  - the nature and form of the marriage service,
  - the vows and commitments they will be asked to make,
  - the relationship of these commitments to their lives of discipleship,
  - the resources of the faith and the Christian community to assist them in fulfilling their marriage commitments.

This discussion is equally important in the case of a first marriage, a marriage after the death of a spouse, and a marriage following divorce.

- C. If the minister is equally convinced after discussion with the couple that commitment, responsibility, maturity, or Christian understanding are so lacking that the marriage is unwise, the minister shall assure the couple of the church's continuing concern for them and not conduct the ceremony. In making this decision the minister may seek the counsel of the session.
- D. Christian marriage should be celebrated in the place where the community gathers for worship. As a service of Christian worship, the marriage service is under the direction of the minister and the supervision of the session. (W-1.4004-4006) The marriage ordinarily takes place in a special service which focuses upon marriage as a gift of God and as an expression of the Christian life. Celebration of the Lord's Supper at the marriage service requires the approval of the session, and care shall be taken that the invitation to the Table is extended to all baptized present. The marriage service may take place during the Service for the Lord's Day upon authorization by the session. It should be placed in the order as a response to the proclamation of the Word. It may then be followed by the Sacrament of the Lord's Supper. (W-2.4010; W-3.3503)
- E. The service begins with the scriptural sentences and a brief statement of purpose. The man and the woman shall declare their intention to enter into Christian marriage and shall exchange vows of love and faithfulness. The service includes appropriate passages of Scripture, which may be interpreted in various forms of proclamation. Prayers shall be offered for the couple, for the communities which support them in their new dimension of discipleship, and for all who seek to live in faithfulness. In the name of the triune God the minister shall declare publicly that the woman and the man are now joined in marriage. A charge

may be given. Other actions common to the community and its cultures may appropriately be observed when these actions do not diminish the Christian understanding of marriage. The service concludes with a benediction.

- F. Music suitable for the marriage service directs attention to God and expresses the faith of the church. (W-2.1004) The congregation may join in hymns and other musical forms of praise and prayer. Flowers, decorations, and other appointments should be appropriate to the place of worship, enhance the worshipers' consciousness of the reality of God, and reflect the integrity and simplicity of Christian life. (W-1.3034; W-1.4004-1.4005; W-5.5006)
- G. A service of worship recognizing a civil marriage and confirming it in the community of faith may be appropriate when requested by the couple. The service will be similar to the marriage service except that the opening statement, the declaration of intention, the exchange of vows by the husband and wife, and the public declaration by the minister reflect the fact that the woman and the man are already married to one another according to the laws of the state.

## **II. Planning for Your Wedding**

- A. We want your wedding to be a meaningful and significant beginning for your life together. We assure you of our desire to do everything possible to make it so.
- B. In planning for your wedding, it is advisable to have an initial conference with the minister as soon as possible. The date of the wedding should be cleared with the church secretary and finalized with the officiating minister. Dates and times are set according to the minister's schedule and the availability of the church facilities.
- C. The wedding shall be under the sole direction of the officiating minister. You may request the minister of your choice from the church staff or one of the ministers will be assigned to work with you. It is the policy of the church that marriage ceremonies in this church be performed by one of the staff ministers.
- D. If you desire to ask another clergy person to assist in the service, you should make your desire known to the officiating minister so that an invitation may be extended to the guest clergy.
- E. At least one, but preferably three, counseling sessions must be scheduled with the officiating minister before the wedding. Please feel free to call upon that minister for advice and counsel at any time.
- F. If the church is already decorated for a scheduled event (such as Easter or Christmas), it is preferable to use the existing seasonal decorations in your wedding decoration theme. The paraments on the pulpit and communion table will be changed to white. The church's candelabra may be used. The church has wedding banners that may be used.
- G. The communion table may not be moved. Aisle runners are discouraged.
- H. The sanctuary, main floor, seats 300 persons with an additional 200 in the balcony. The chapel seats 60.
- I. The use of any alcoholic beverage or illegal drug is prohibited in the church building and in all adjacent parking areas. Persons under the influence will not be permitted to be a part of the wedding ceremony. The church building is also a smoke-free environment.

### III. Wedding Fees

The church makes every effort to assist families in keeping costs at a minimum. Weddings, however, do involve extra services which the church is unable to underwrite. Members (*members of the church are considered to be either the bride or the groom or at least one of their parents*) are asked to pay the following.

There is no fee for the pastor's services. An honorarium is appropriate.

### IV. Music for Your Wedding

- A. The organist of the church will play for all weddings in the church or secure a substitute. The bride and groom should consult with the organist at least one month in advance of the wedding date, being guided by the information on page 8: AMERICAN GUILD OF ORGANISTS.
- B. The choice of vocal and/or instrumental soloists and music must be approved by the officiating minister and/or the organist before the additional musicians are engaged.
- C. Please see pages 9, 10 and 11: WEDDING MUSIC.

### V. Rehearsals, Receptions, Photographs, Videotaping

- A. The rehearsal is usually held on the day preceding the wedding and is conducted by the officiating minister. One hour should be reserved for the rehearsal and promptness at rehearsals is expected. Members of the wedding party shall conduct themselves, at all times, in a manner befitting the atmosphere of a place of worship, and it is the obligation of the bride and groom to make certain that this expectation is known and observed by members of the wedding party.
- B. Arrangements for all soloists and special music shall be made through Arlene Gray (home phone: 250-0860; work phone BSC 224-5510; and would normally be scheduled during office hours. Messages may be left on home voice mail.
- C. Wedding receptions can be scheduled for the church parlor or for Ramstad Hall using a caterer, under church supervision. (Information available on request from the church office.)
- D. A room near the parlor is reserved for the bride and her attendants. The groom and his attendants may dress downstairs and wait in the parlor.
- E. Finger food, such as a meat and cheese tray with crackers, is allowed. A refrigerator is available for bottled water, soft drinks or juice.
- F. Weddings are scheduled at least four hours apart. A wedding party may arrive at the church as early as four hours prior to the wedding.
- G. The ushers shall arrive at least one hour before the wedding. They shall be responsible for seating the guests, lighting and extinguishing the candles, and ushering out parents and guests after the recessional.

- H. Photographs are permitted in the sanctuary up to 45 minutes before the ceremony and afterwards. Photographs may be taken during the processional and recessional by a designated photographer. During the ceremony, photographs may be taken only by a designated photographer and only from the narthex entrance or the balcony, as quietly as possible, with existing light only. No flash photographs are permitted during the ceremony. The marriage ceremony is a service of worship and any outside intrusion disturbs the reverence that should be a part of the service.
- I. Guests shall be asked not to take pictures during the processional, ceremony, or the recessional.
- J. Video photographing of the ceremony is permitted, providing that the equipment and the photographer are located at the back of the sanctuary or in the balcony with the equipment on a tripod. Video taping is not permitted within the chancel area.
- K. Wedding party decorations are to be removed directly following the wedding.

## **VI. Miscellaneous**

- A. Guests are requested not to use rice or confetti on the church premises.
- B. The marriage license shall be presented to the officiating pastor at least two days before the rehearsal. The bride and groom are to contact the clerk of the county to discover current requirements for obtaining a marriage license.
- C. Weddings will not normally be scheduled on the following days:  
Maundy Thursday, Good Friday, the Saturday before Easter, Easter Day, Memorial Weekend, Fourth of July Weekend, Labor Day Weekend, Thanksgiving Day, December 24 and 25th, or any other day that the church building is scheduled to be closed.
- C. One of the church's wedding coordinators, Judy Lentz, 255-3590, or Beth Lipp, 223-6091, will be your contact person for wedding policy and procedures. A coordinator will be assigned shortly after your wedding date is set.
- D. Decorating may be done on the day of rehearsal or the day of the wedding. The wedding coordinator will be present to supervise.

# American Guild of Organists

## Wedding Music Guidelines

The wedding is a service of worship and should therefore be planned with that in mind. The music is an integral part of the service and should be chosen with care.

The organist of the church should be given the first choice of playing for all weddings at his or her church. If for some reason the regular organist is not able to play for the wedding, it is courteous for the bridal couple to consult with the regular organist in finding a replacement.

The organist will provide appropriate music prior to the wedding service and following the recessional. The processional and recessional music is chosen in consultation with the couple.

The soloist should be capable of performing the music you choose and not require the assistance of the organist to learn the music. The organist is responsible for rehearsing with and accompanying the soloist during the wedding service. Copies of the music (not photocopies) should be provided to the organist at least two weeks before the wedding.

## Fees

The organist's fee should be paid before the ceremony at the time of the rehearsal. The fee includes a consultation with the bridal couple. Accompanying the soloist is also included in the fee unless the number of songs requires extra rehearsal time. In that case the organist may ask for additional compensation. Because church music is a ministry, members of the AGO are willing to discuss the fee if financial limitations would prevent the couple from having music at their wedding.

The organists' time involves not only the wedding and rehearsal, but also the consultation time, preparation time for the music and rehearsal time with the soloist. The Missouri Valley Chapter, AGO, does not intend to recommend the fee paid to soloists. However, we believe that the compensation paid to the organist should be above that paid to soloists, because of the greater portion of the service that is the responsibility of the organist and the time required for proper preparation.

# Wedding Music

The Christian marriage ceremony is a sacred service of worship. Therefore, the music chosen for the service should be a part of the worship experience. Popular love songs or sentimental ballads can be used at the reception after the ceremony. Organ music that was written for entertainment rather than worship should not be used as a part of the service.
